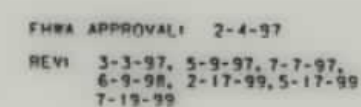

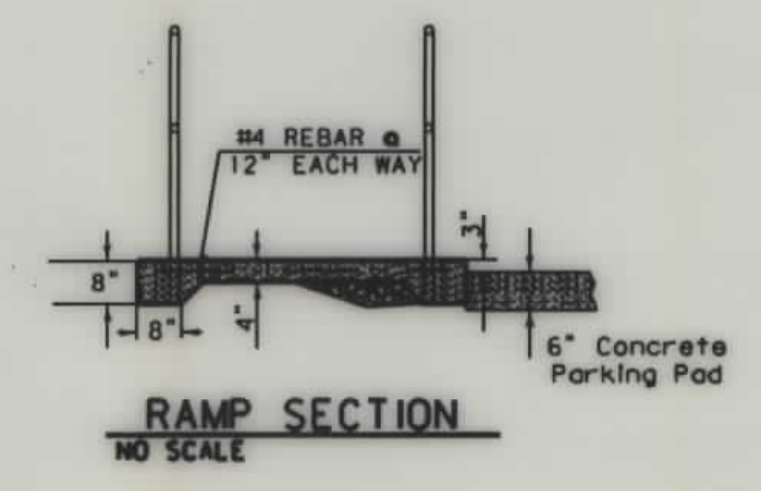
RAMP PLAN

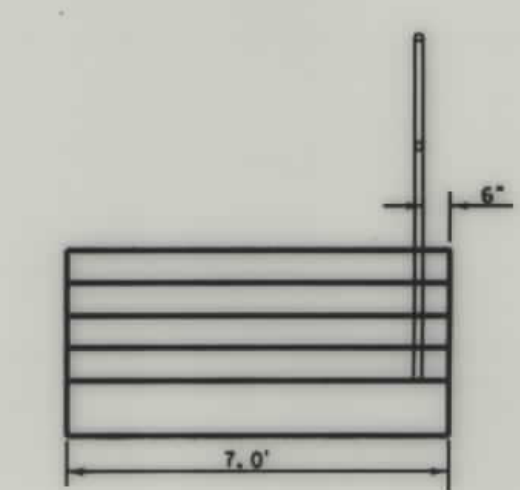

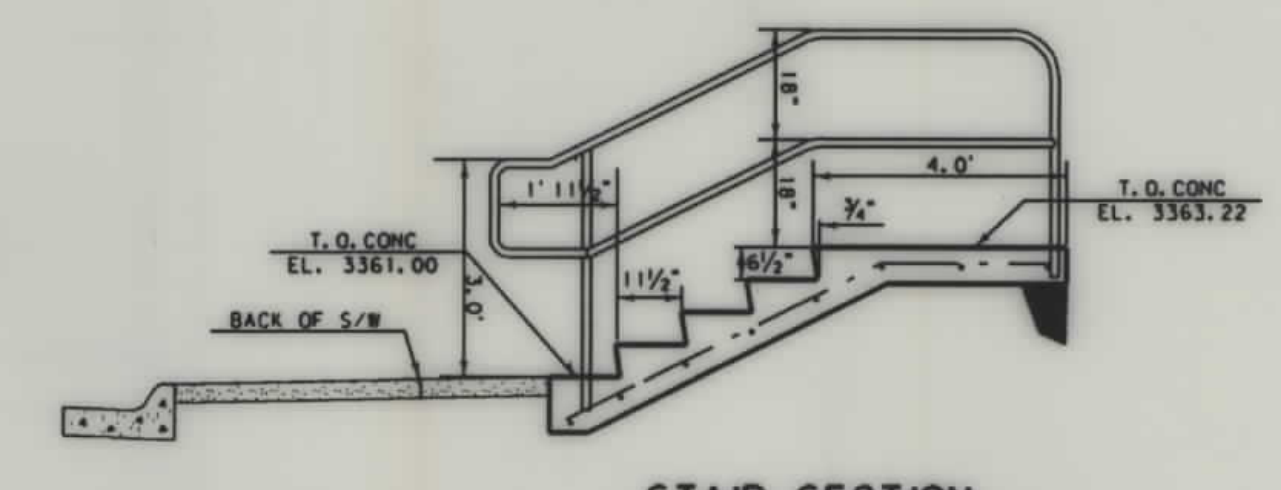
RAIL EMBED DETAIL

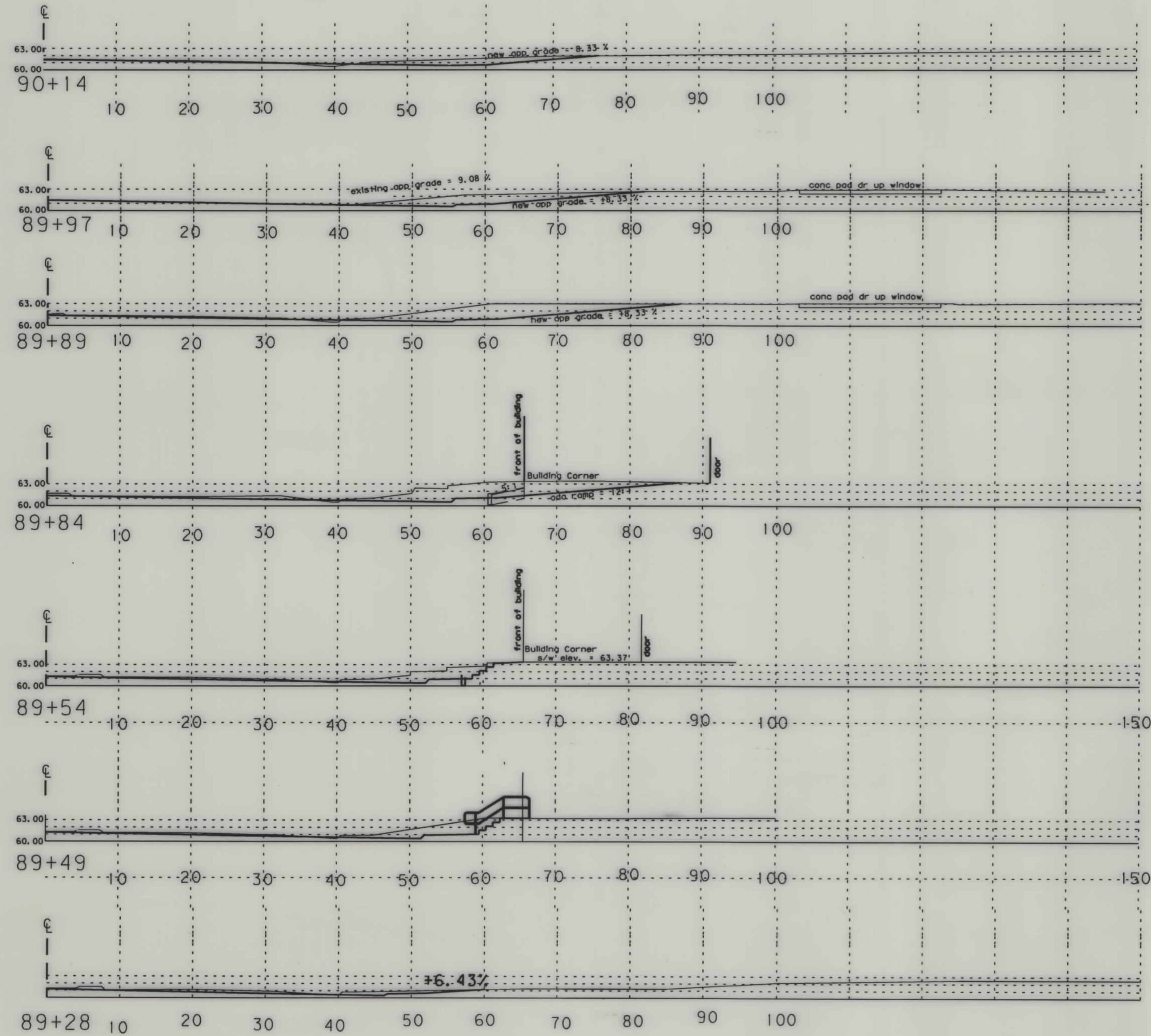
